2018-2019 Service Contract**

**Introduction**

It is the mission of the Ross County Board of Developmental Disabilities to improve lives by supporting choices of people through community partnerships and quality services. We believe that our partnership with the Miami Trace Local School District enhances our mission through a collaborative effort of providing Special Education services for individuals with developmental disabilities.

**Subscribers**

**Services to be provided by RCBDD as agreed upon by both parties:**

*Services prescribed per the Individual Educational Plan (IEP) for: 3 Students (See SSID Numbers Listed Below) with RCBDD listed as the District of Service*

- Evaluation, Assessments, Screenings
  - Behavior Plans and Associated Interventions
  - Nursing-School RN and LPN available throughout the day
  - Referrals to services for classroom supports
  - Therapies may include: Speech, Physical, Occupational, Behavioral, Music and Adapted Physical Education throughout the school year. Summer Therapy Programming available upon parent/guardian permission.
    - RCBDD is responsible for data entry to the Ohio School Medicaid program on behalf of district.
  - Recreational Opportunities & Community Trips

- Curriculum and programming materials not associated with individual need
- District is responsible for transportation and costs associated with transportation.
- District is responsible for implementation of district policy regarding HB 410. RCBDD is responsible for reporting attendance monthly to district. Notification will also be made if action is required under HB 410.

**Rate:**

Services will be reimbursed to the Ross County Board of DD at the annual rate of \$30,000 per student that will be invoiced at \$45,000.00 at half year increments in January and June for a total of \$90,000.00 for the 2018-19 school year for three students.

**One to One Classroom Aide**

Services for a full-time one to one aide for SSID #UV2193909 will be billed at the cost quote of \$36,852.88. Cost will be prorated according to official date of hire.

**Documentation of Service**

This service contract shall become effective upon signature of both subscribers and shall remain in effect until June 30, 2019. All out of county placements serviced through contracts with LEA's will be evaluated annually based on our open enrollment procedure. All services will be documented with:
