OHIO PRO DJ AGREES TO PERFORM LIVE DISC-JOCKEY SERVICES FOR:

Agreement/Jurisdiction: The person(s) whose signature(s) appear on this contract, known as "Client", agree that Ohio Pro DJ, known as "Disc Jockey", shall provide services to entertain Client to the best of their abilities, in the manner described in this document. This is a binding contract which incorporates the entire understanding of the parties, and any modifications must be in writing, signed by both parties, and physically attached to the original agreement. The laws of the State of Ohio shall govern this contract, and any resulting arbitration shall take place within Madison County, Ohio. Client assumes responsibility for all collection costs and legal fees incurred by Disc Jockey should enforcement of this contract become necessary. In the event that any part of this Agreement is found to be invalid or unenforceable, the remainder of this agreement shall remain valid and enforceable. Any failure by one or both parties to enforce a provision of this agreement shall not constitute a waiver of any other portion or provision of this agreement.

Payment: Client shall reserve the time and date of services by signing and returning this contract. No date is reserved until the signed contract is received.

The balance due for the Disc Jockey services must be paid in full on the day of event. Returned checks will be assessed a \$35 non-sufficient funds fee, and all future purchases/payments must be paid by Cashiers Check, or Cash.

Cancellation: If for any reason Client cancels this contract before the event date, a cancellation notice must be made in writing, signed by the contracted party, and a Ohio Pro DJ representative.

Reschedule: In the event that Client reschedules the event, and Disc Jockey is able to re-book the new event date, Client will receive credit for all monies already paid. A new contract may be required. The new contracted price will reflect the current rate, if it has changed, and is non-negotiable.

Liability: If Disc Jockey is unable to perform any or all of the duties herein for any reason, including but not limited to, fire, transportation problems, acts of God, accident, illness, or technical problems, and if Disc Jockey cannot provide another competent professional, all money received by Disc Jockey, minus expenses, will be returned to Client, and Disc Jockey shall have no further liability with respect to this agreement. The sole remedy for any actions or claims shall be limited to a refund whose total amount cannot exceed the total monies paid by Client under this agreement during the time preceding the date on which such liability arises.

Liability Insurance: Ohio Pro DJ carries a \$1,000,000 liability insurance policy.

Responsibilities: Unless agreed upon in advance, Ohio Pro DJ shall be the exclusive Disc Jockey retained for the event. Disc Jockey may bring assistants at their discretion. Disc Jockey is not responsible for compromised coverage due to causes beyond their control such as , the lateness of the client, family members, guests, other principles, weather conditions, schedule complications, or restrictions of the venues. Client agrees to confirm the schedule one-week prior to the event. Notification of any changes in schedule or location must be made in a timely manner. Changes can be made by phone, text or e-mail for documentation. If e-mail is sent, confirmation of receipt must be obtained.

Coverage: Disc Jockey will provide coverage for the dates, locations, and continuous hours specified in this agreement. In the unlikely event an emergency that would prevent Disc Jockey from performing the services agreed upon above, the representative listed on this contract would be contacted immediately, and alternate arrangements would be made as described under the "liability" section.

Overtime: Disc Jockey is available to play over the contracted time at a rate of \$50 per 30 minutes. However, permission must be granted from the facility where the services are being performed, and must be paid in full before any additional entertainment starts.

Weather: Disc Jockey reserves the right to shut down sound and or light systems should there be any threat of harm made to anyone in attendance, including but not limited to, Rain, Lightning, Hail or any other Act of God that may present harm.

Lighting: Disc Jockey may bring lighting systems that strobe, flash, and move. Disc Jockey is not liable, or responsible if a guest has a medical issue that results from said lighting effects. Client may request in writing that such effects be prohibited at event.

Fog Machine: Disc Jockey may bring a non-toxic fog machine. Disc Jockey is not liable, or responsible if a guest has a medical issue that results from said fog machine. Client may request in writing that such effects be prohibited at event.

Ohio Pro DJ Performance Requirements:

Please provide a 6 foot long, skirted table located within 25 feet of an electrical outlet on the day of the event.

Payments

Final payment of the event is due on the day of the event.
